

## Chapter 225. Health and Sanitation

### Article II. Board of Health

#### Section 225.020. Established.

[CC 1971 §13-12; Ord. No. 413 §1, 6-3-1940]

There is hereby constituted and established for the City a Board of Health.

#### Section 225.030. Composition.

The Board of Health shall consist of the Mayor, who shall be the ex officio President of the Board, the City Health Officer and at least one (1) other member, or however many the Mayor deems necessary, who shall be a resident of the City.

#### Section 225.040. Appointment.

The Mayor shall appoint some qualified person as Health Officer for the City and the other members of the Board with the advice and approval of the Board of Aldermen.

#### Section 225.050. Terms.

The Mayor shall serve on the Board for a term concurrent with his/her office as Mayor, and the City Health Officer and the other members of the Board of Health shall serve for terms of two (2) years or until their successor is appointed and qualified.

#### Section 225.060. Quorum.

A simple majority of the members of the Board of Health shall constitute a quorum for the transaction of business.

#### Section 225.070. Secretary.

The Board of Health shall appoint one of its members as Secretary for the Board, who shall record the proceedings of the Board in general and perform all other clerical duties prescribed by the Board.

#### Section 225.080. Rules and Regulations.

The Board of Health shall have the power to adopt rules and regulations for its government, not in conflict with the provisions of this Code or ordinances of the City.

#### Section 225.090. Right of Entry.

The Board of Health shall have the power to enter into and examine any and all buildings, lots and other places of every kind and description which, in the opinion of the Board, may be dangerous to the public health.

#### Section 225.100. Control of Nuisances.

The Board of Health shall have the power to declare and abate nuisances found within the City in the manner provided by this Code, State law or City ordinances, rules or regulations.
