• Thursday, March 28, Geib and 2 city workers waited for the delivery of the new playset. It did not arrive and there was miscommunication on the company's part. The playset arrived on Monday, April 1, 2024. Unfortunately, it did not get sent in the correct colors. Geib contacted the company and they were willing to remake the set in the correct colors that were in the order submitted. Clint made a motion to reorder the playset in the correct colors. Andrea seconded. All votes aye.

- Todd King and David Wedel hauled off the scrap metal that was in the park. Todd then donated the money from the scrap iron back to the city park (\$186.00).
- We need to schedule a work day for this spring. We have tabled this now that the new playset is incorrect. We will schedule this once the correct playset is delivered and ready to be installed.
- We need wood chips to replace the wood chips throughout the park. Typically 90 cubic yards costs a total of \$2600. Geib called the company that we typically use and received a quote for a delivery and was given a total of \$4200. Clint brought up the idea of tire mulch. Geib and Roup will do some research about tire mulch and wood mulch to bring to the April 10th meeting.
